Stabling

No stall reservations will be accepted unless accompanied by a horse entry. All stall fees are absolutely NON-REFUNDABLE, NO EXCEPTIONS. We will do our best to re-sell a stall if we are given notice, but failing that, all stall charges are the responsibility of the person who reserved it. Stall fees are \$55.00, shavings are \$8.00 per bag. Please see the attached stabling form or download it from our website. Trainer stall split sheets are also available. In order to avoid confusion, please include the name of your trainer/barn and your horse's name on the stall request form. **Please be advised that due to covid protocols you must pre-order your shavings if you wish to have them. Covid protocols dictate that we are unable to deliver shavings during the show day.**

Ribbons will be awarded to eighth (8) place.

This bronze competition is a sanctioned competition of Equestrian Canada 308 Leggett Dr. #100, Ottawa, ON K2K 1Y6 and every class offered herein is covered by the rules and specifications of the current rules of EC and will be held and judged in accordance with the EC rule book. Any horse entered in any class at the competition may be selected for equine medication control testing while at the event location.

**RULES AND REGULATIONS:**

1. Any rider(s) entering bronze classes or divisions at this horse show, and any person or group listed as the owner(s) in the EQUESTRIAN CANADA (EC) Competition Horse recording of any horse or pony entered in any class or division at this horse show MUST be current bronze or higher members in good standing of EC and the Ontario Equestrian (OE) and must supply original or photocopy of their 2020 membership cards at the show.



2. Entries must be received on or before the closing date to avoid post entry fees. Closing date is the SUNDAY BEFORE SHOW DATE, 8:00pm. Entries received after Sunday 8:00pm before the show date will be assessed a \$25.00 fee. **\*PLEASE NOTE THAT WE MAY BE UNABLE TO ACCEPT POST ENTRIES!!** It is the responsibility of the entrant to provide proof of timely entry submission should there be a disagreement regarding time of entry. All entries will be marked with date and time of reception.

3. **Refunds: Administration, Covid and stall fees are not refundable. NO EXCEPTIONS.** Entry fees will be returned if cancelled in the show office in writing 24 hours prior to the first class entered with proper medical documentation. Once a horse has entered the show grounds, there will be no refund unless authorized by the show committee. Scratch Fees\*\* No telephone entries or scratches can be accepted. Scratched entries providing notification 24 hours in advance without a veterinary certificate will be assessed the covid fee and the administration fees, class/division fees will be waived. All unpaid fees will be considered an outstanding account until paid in full. Any classes/divisions entered but not completed will be charged. There will be no refund for classes scratched on the day of competition for any reason.

4. No entries will be accepted without a signed open cheque, and a non refundable prepayment of \$75.00. This can be emailed to : [jokershorseshows@gmail.com](mailto:jokershorseshows@gmail.com) . If stalls are required, they must also be prepaid and are non-refundable. E transfers can be made using the password: ce2020. Please make cheques payable to Show Facility / Management. No numbers will be issued to any horse or rider for whom an entry form has not been fully completed. **NO ENTRY WILL BE ACCEPTED FOR EXHIBITORS NOT IN GOOD STANDING.** All outstanding accounts must be paid in full before an entry can be accepted and processed. All outstanding accounts will also be forwarded to other show managers for collection at their competitions.

5. All **NO SHOW** entries, including faxed-in entries, will be charged full entry fees and all other applicable fees. All accounts must be settled prior to the next show, otherwise entries will be denied. Please note any outstanding accounts will not be eligible to receive circuit awards.

6. A \$50.00 charge will be added to all accounts paid with cheques that are returned from the bank for any reason.

7. Show Management reserves the right to change or amend show scheduling up to one (1) hour prior to the designated class.

8. Under NO circumstances will a PHONED IN entry, stabling request, or cancellation be accepted.

9. **NO CELL PHONE PICTURES OF ENTRIES WILL BE ACCEPTED.**

10. Any and all dogs MUST BE LEASHED at the show.

11. Protests, if any, must be made in writing and must be in the hands of the secretary within 48 hours of completion of the class concerned. No protest will be considered unless accompanied by a deposit of \$50.00 that shall be forfeited to the committee if said protests are not sustained. Protesting an animal's height carries a \$100.00 cash deposit.

NOTE: Protests are usually made through the steward of the horse show. Also available at the horse show office are *Exhibitor Report Forms*. These require no cash deposit and may be submitted to the show office, the steward or sent directly to the O.E.

12. In the event of a fall of horse and/or rider, the competitor must leave the ring dismounted.

13. Back numbers MUST be worn/visible at ALL times while mounted. Proper show attire, including jackets, is required for all divisions and classes, including all jumper divisions and judged warm-up classes, unless excused by judge or show management.



NOTE: Jumper riders are expected to bring show jackets to ride in their classes.

Individual show managers may make specific decisions regarding this rule, but jackets are NOT excused unless announced. Exhibitors without jackets may not be permitted to show.

14. Jumper classes, unless otherwise indicated in the Horse Show Prize List and Show Program, will be run under Article 238. The use of draw reins is not permitted.

15. Approved headgear: All competitors must wear proper fitting, approved protective headgear, with the safety harness correctly secured, at all times while mounted on competition or event grounds. Approved headgear meets the ASTM (American Society for Testing Materials) standards and displays the SEI (Safety Equipment Institute) seal. The British standard, BSI is also acceptable.

16. Management reserves the right to limit or close the entries of any classes or divisions in an effort to adhere to the timetable.

17. All entry forms must be signed by the competitor if they are an adult and must have a parent or guardian signature for juniors. No competitor will be allowed to show without the required signature and will be liable for administration fees and scratch fees.

18. Hors Concours rounds will not be permitted.

### **COVID 19 PROTOCOLS**

19. Any persons who do not follow the appropriate mandatory social distancing and covid protocols will be removed from the property and forfeit any monies paid. Face masks are highly recommended for anyone who is not mounted.

20. Only essential participants (rider/trainer/parent if minor) are allowed on the grounds. There will be no spectators allowed. Only one access point to the property and temperature checks and/or verbal health checks will be conducted by the monitor.

21. The property will be divided into zones to control participant numbers and entry to and from each zone will be regulated.

22. Day stabling will be available at limited capacity. Those areas will be restricted to the riders/trainers. Stalls will be gutted and disinfected prior to new occupancy. Competitors are permitted to work off their trailer while following social distancing protocols.

23. We will be using a "Show and Go" format with estimated show times. Competitors are strongly encouraged to arrive shortly before their posted time and depart soon after. Trainers are encouraged to have grooms available to care for the horses to enable competitors who are finished to leave.

24. Indoor washrooms will be closed but there will be Portapotties available near the rings with handwashing stations. These will be cleaned and disinfected on an on-going basis.

25. **ALL ESSENTIAL PARTICIPANTS MUST PROVIDE A MOBILE NUMBER AND A VALID EMAIL ADDRESS**

26. If possible, please be prepared to use E-transfers for contactless payment. We are encouraging contactless payment.



## EQUESTRIAN CANADA STATEMENT OF PRINCIPLE

EQUESTRIAN CANADA, the National Federation of Canada, supports adherence to humane treatment of horses in all competitions under its jurisdiction. EQUESTRIAN CANADA is committed to: Upholding the welfare of horses, regardless of value, is a primary consideration in all activities. Requiring that horses be treated with kindness, respect, and the compassion that they deserve, and that they never be subjected to mistreatment. Ensuring that owner, trainer, exhibitors and their agents use responsible care in the handling, treatment and transportation of their horses as well as horses placed in their care for any purpose. Providing for the continuous wellbeing of horses by encouraging routine inspection and consultation with health care professionals and competition officials to achieve the highest possible standards of nutrition, health, comfort, sanitation and safety as a matter of standard operating procedure. Continuing to support scientific studies on equine health and welfare. Increasing education in training and horsemanship practices. Requiring owners, trainers and exhibitors to know and follow their sanctioning organization's rules and to work within industry regulations in all equestrian competitions. Reviewing, revising and developing competition rules and regulations that protect the welfare of horses. The standard by which conduct or treatment will be measured is that which a reasonable person, informed and experienced in generally accepted equine training and exhibition procedures, would determine to be neither cruel, abusive nor inhumane. All participants at Central East Alliance shows are expected to abide by this statement of Principle.

All horses attending Equestrian Canada sanctioned competitions must have met the requirements of Article A519, Vaccinations. See Rules of Equestrian Canada, Section A, General Regulations, Article A519, Vaccinations.

As per article A801 every entry at an EC sanctioned competition shall constitute an agreement by the person responsible that the owner, lessee, trainer, manager, agent, coach, driver or rider and horse shall be subject to the EC constitution and all rules of EC and any additional rules set by the competition.

### WAIVER STATEMENT FOR ENTRY – ALL COMPETITORS (OR PARENTS/GUARDIANS IN THE CASE OF A JR.) MUST AGREE THAT BY SUBMITTING THE ENTRY :

ENTRY AGREEMENT WAIVER: In the event that \_\_\_\_\_ participates in an Equestrian Canada sanctioned competition where protective headgear is required for juniors, he/she will wear properly fitted and fastened approved headgear at all times while riding or driving at the event location. It is understood that juniors not meeting this requirement will not be allowed to compete at these competitions. I certify that every horse, rider and/or driver is eligible as entered and agree for myself and my representatives to be bound by the Constitution and rules of Equestrian Canada at this competition. It is hereby recognized that all equestrian sports involve inherent risk and that no helmet or protective equipment can protect against all foreseeable injury. I hereby accept this risk and hold harmless EC, the competition, their officials, organizers, agents, employees and their representatives. The Person Responsible (PR) agrees to the release of any information on the entry form to EC. I hereby certify that every horse listed on this entry form entered in any class at a competition has met the requirements of Article A519, Vaccinations. See Rules of Equestrian Canada, Section A, General Regulations, Article A519, Vaccinations

Schooling rounds are offered at each height – Please select the letter corresponding with your division for entry – for example, for Open 2'9 hunter, select class 100F, for short stirrup, select class 100A. Competitors must leave the ring after two refusals.

#### SHORT STIRRUP HUNTER

Maximum 8 fences, verticals only, max height 21". Riders showing in this division are not eligible to compete in any other divisions over fences. Open to "C" riders. Cross entry only to Short Stirrup Equitation Over Fences. Open to horses and ponies, however lines (distances) will not be adjusted. Ideally horse/rider combination are able to ride all lines with same consistency in rhythm and pace.

There will be no adjustment of striding for ponies showing in this division. Lines will be set at a minimum of 72' with no combinations.
